China → Blida · via ALG air / Algiers sea · clearance by Direction Générale des Douanes, Algeria

Blida is industrial belt south of the capital, and it is served through ALG air / Algiers sea. That combination is what actually sets your delivery date on this lane — the inland leg is same-day, so the clearance date is effectively the delivery date.

On the destination side, Direction Générale des Douanes, Algeria handles clearance; budget 10–20 days of dwell before the cargo is released.

Duty, tax and clearance into Blida

Direction Générale des Douanes, Algeria assesses duty and tax on cargo arriving for Blida consignees. Current regime: VAT 19%; duty 5–60%, plus additional safeguard duty (DAPS) of up to 200% on some consumer goods, with a de-minimis position of No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Certificate of conformity and bank domiciliation of the import contract required before shipment. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Algeria: Bank domiciliation of the import contract is mandatory before shipping. DAPS safeguard duty applies to a long list of finished goods. Import bans and quotas on certain categories change with policy — verify at booking.

What the routing looks like in practice

Algeria protects domestic production aggressively, and the additional safeguard duty on finished consumer goods can dwarf the base tariff. Every commercial import also has to be domiciled with an Algerian bank before shipment, which links the logistics timetable to the consignee's banking arrangements. Treat the license and domiciliation as the critical path.

What to sort out before the cargo leaves China

- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.
- Put the Blida delivery address, contact name and phone number on the invoice, not just the packing list.
- Compare gross weight against volumetric weight (L×W×H ÷ 6000) — the higher figure is what gets billed on air and express.
- Budget for the inland leg: same-day delivery beyond gateway clearance to reach Blida.
- Ask for the HS code in writing from your supplier and verify the Algeria duty rate against it yourself.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.

Frequently asked questions

How long does shipping from China to Blida take?

China to the Algeria gateway is 5–8 business days by air, 24–32 calendar days by sea. On top of that, allow 10–20 days of clearance with Direction Générale des Douanes, Algeria and a same-day inland leg to Blida.

What duty and tax will I pay importing into Blida?

Direction Générale des Douanes, Algeria applies: VAT 19%; duty 5–60%, plus additional safeguard duty (DAPS) of up to 200% on some consumer goods. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Blida.

What documents does Direction Générale des Douanes, Algeria require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Certificate of conformity and bank domiciliation of the import contract required before shipment). We prepare and file these as part of the service.

When is the busiest time on the China–Algeria lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

Which port or airport does cargo for Blida clear through?

Cargo for Blida is routed via ALG air / Algiers sea. Sea gateways for Algeria are Algiers, Oran, Béjaïa; air gateways are ALG (Algiers), ORN (Oran). We pick whichever gives the shortest total door time for your address.

Is sea freight cheaper than air freight into Blida?

Per kilo, yes — usually by a wide margin. The trade-off is time: 24–32 calendar days by sea versus 5–8 business days by air to the Algeria gateway, before clearance and the same-day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Algeria duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Direction Générale des Douanes, Algeria against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
