China → Gazipur · via DAC air / Chattogram sea · clearance by National Board of Revenue (NBR), Bangladesh Customs

For buyers shipping into Gazipur, the practical question is not the ocean or flight time but what happens after arrival. Gazipur is the largest concentration of garment factories; cargo enters through DAC air / Chattogram sea, and allow +1 day for the inland leg on top of clearance.

The clearing authority is National Board of Revenue (NBR), Bangladesh Customs. Historical dwell on this gateway is around 7–15 days, and it lengthens in Sep-Dec.

Routing and transit on this lane

Chattogram is chronically congested and dwell of 7–15 days is normal rather than exceptional. Because commercial imports generally require a letter of credit opened by the consignee, the payment structure has to be agreed before the cargo is booked — this is the main reason DDP quotes fall apart on the Bangladesh lane.

Duty, tax and clearance into Gazipur

National Board of Revenue (NBR), Bangladesh Customs assesses duty and tax on cargo arriving for Gazipur consignees. Current regime: VAT 15%; customs duty 0–25% plus supplementary duty, advance income tax and advance tax — the effective landed burden is often 30–100%, with a de-minimis position of No practical de-minimis.

Conformity is the part most first-time importers underestimate: BSTI certification for regulated goods; a letter of credit is mandatory for most commercial imports. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Bangladesh: LC-based import documentation must match the shipping documents exactly. Supplementary duty on consumer goods can exceed the base duty. Garment-sector inputs may qualify for bonded-warehouse relief tied to the factory license.

What to sort out before the cargo leaves China

- Book earlier than the transit time suggests during Sep-Dec, when space on this lane tightens.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Get the conformity paperwork moving early: BSTI certification for regulated goods; a letter of credit is mandatory for most commercial imports.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Budget for the inland leg: +1 day beyond gateway clearance to reach Gazipur.

Frequently asked questions

How long does shipping from China to Gazipur take?

China to the Bangladesh gateway is 3–6 business days. On top of that, allow 7–15 days of clearance with National Board of Revenue (NBR), Bangladesh Customs and a +1 day inland leg to Gazipur.

What duty and tax will I pay importing into Gazipur?

National Board of Revenue (NBR), Bangladesh Customs applies: VAT 15%; customs duty 0–25% plus supplementary duty, advance income tax and advance tax — the effective landed burden is often 30–100%. The de-minimis position is No practical de-minimis. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Gazipur.

Can you deliver door-to-door in Gazipur?

Yes. Delivery to a Gazipur address is quoted as one figure covering freight, duty and tax owed to National Board of Revenue (NBR), Bangladesh Customs, and the +1 day inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

Which port or airport does cargo for Gazipur clear through?

Cargo for Gazipur is routed via DAC air / Chattogram sea. Sea gateways for Bangladesh are Chattogram (Chittagong), Mongla, Matarbari; air gateways are DAC (Dhaka), CGP (Chattogram). We pick whichever gives the shortest total door time for your address.

When is the busiest time on the China-Bangladesh lane?

Space and rates tighten around Sep-Dec, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

How is the chargeable weight calculated for Gazipur?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Bangladesh duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by National Board of Revenue (NBR), Bangladesh Customs against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

On the air side, anything with a cell or a battery in it, plus liquids, powders, magnets and aerosols, is governed by [the IATA Dangerous Goods Regulations](#). Those articles are not refused outright, but they need to be declared at booking so the shipment is built correctly — declaring them late is the single most common cause of an air consignment being offloaded.

If this is your first shipment into Bangladesh, the [Bangladesh Country Commercial Guide](#) covers the practical import environment in more depth than a rate page reasonably can, and it is written by a party with no stake in your booking.
