China → Gitega · via BJM air / Dar es Salaam transit · clearance by Office Burundais des Recettes (OBR)

We move air freight cargo from South China into Gitega through BJM air / Dar es Salaam transit. Gitega is the political capital in the interior, which shapes the kind of cargo that moves on this lane and how it should be packed.

On the destination side, Office Burundais des Recettes (OBR) handles clearance; budget 10-20 days of dwell before the cargo is released.

Routing and transit on this lane

Burundi sits at the end of the longest inland corridor in East Africa — roughly 1,400 km from Dar es Salaam. The road leg is the dominant cost and time factor, frequently exceeding the ocean freight itself, and the Central Corridor's condition varies by season. Quote the inland leg explicitly rather than folding it into a single figure.

What you will pay on arrival in Burundi

Imports into Burundi are cleared by Office Burundais des Recettes (OBR). The headline position is: VAT 18%; EAC common external tariff 0–35%. The de-minimis threshold is No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Pre-export verification of conformity for regulated goods; EAC certificate of origin where applicable. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Burundi: Inland corridor transit through Tanzania requires bonded documentation and is the main schedule risk. Foreign-currency availability constrains duty settlement. PVoC conformity applies to regulated goods.

Pre-shipment checklist for Gitega

- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Budget for the inland leg: +3 days beyond gateway clearance to reach Gitega.
- Book earlier than the transit time suggests during Sep-Dec, when space on this lane tightens.
- Get the conformity paperwork moving early: Pre-export verification of conformity for regulated goods; EAC certificate of origin where applicable.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Confirm the consignee in Gitega can act as importer of record — Office Burundais des Recettes (OBR) will not release cargo to an unregistered party.

Frequently asked questions

How long does shipping from China to Gitega take?

China to the Burundi gateway is 6–9 business days. On top of that, allow 10–20 days of clearance with Office Burundais des Recettes (OBR) and a +3 days inland leg to Gitega.

What duty and tax will I pay importing into Gitega?

Office Burundais des Recettes (OBR) applies: VAT 18%; EAC common external tariff 0–35%. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Gitega.

Can you deliver door-to-door in Gitega?

Yes. Delivery to a Gitega address is quoted as one figure covering freight, duty and tax owed to Office Burundais des Recettes (OBR), and the +3 days inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

When is the busiest time on the China-Burundi lane?

Space and rates tighten around Sep-Dec, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

How is the chargeable weight calculated for Gitega?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

What documents does Office Burundais des Recettes (OBR) require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Pre-export verification of conformity for regulated goods; EAC certificate of origin where applicable). We prepare and file these as part of the service.

Checking the Burundi duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Office Burundais des Recettes (OBR) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

On the air side, anything with a cell or a battery in it, plus liquids, powders, magnets and aerosols, is governed by [the IATA Dangerous Goods Regulations](#). Those articles are not refused outright, but they need to be declared at booking so the shipment is built correctly — declaring them late is the single most common cause of an air consignment being offloaded.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
