China → Phnom Penh · via PNH air / Phnom Penh river port · clearance by General Department of Customs and Excise (GDCE)



Cargo handling on the China-Phnom Penh lane.

Freight from China into Phnom Penh clears through PNH air / Phnom Penh river port. Phnom Penh is capital, largest market and main clearance point, and the inland leg is same-day, so the clearance date is effectively the delivery date.

On the destination side, General Department of Customs and Excise (GDCE) handles clearance; budget 3–7 days of dwell before the cargo is released.

Routing and transit on this lane

Sihanoukville takes direct South China calls, while Phnom Penh is reachable by river barge from Cai Mep in Vietnam — often the cheaper option for LCL. Land trucking through the Bavet crossing from Ho Chi Minh City is a practical third route for urgent cargo that does not justify air.

Duty, tax and clearance into Phnom Penh

Imports into Cambodia are cleared by General Department of Customs and Excise (GDCE). The headline position is: VAT 10%; duty 7–35%, with ACFTA and RCEP preference on a Form E. The de-minimis threshold is No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: CamControl inspection for regulated goods; Form E for duty preference. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Cambodia: Garment and footwear inputs move under specific duty-exemption schemes tied to the factory license, so the consignee's status changes the landed cost materially. Used goods and secondhand electronics face restrictions.

Pre-shipment checklist for Phnom Penh

- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Put the Phnom Penh delivery address, contact name and phone number on the invoice, not just the packing list.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Confirm the consignee in Phnom Penh can act as importer of record — General Department of Customs and Excise (GDCE) will not release cargo to an unregistered party.
- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.

Frequently asked questions

How long does shipping from China to Phnom Penh take?

China to the Cambodia gateway is 6–10 calendar days. On top of that, allow 3–7 days of clearance with General Department of Customs and Excise (GDCE) and a same-day inland leg to Phnom Penh.

What duty and tax will I pay importing into Phnom Penh?

General Department of Customs and Excise (GDCE) applies: VAT 10%; duty 7–35%, with ACFTA and RCEP preference on a Form E. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Phnom Penh.

Can you deliver door-to-door in Phnom Penh?

Yes. Delivery to a Phnom Penh address is quoted as one figure covering freight, duty and tax owed to General Department of Customs and Excise (GDCE), and the same-day inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

Is sea freight cheaper than air freight into Phnom Penh?

Per kilo, yes — usually by a wide margin. The trade-off is time: 6–10 calendar days by sea versus 3–5 business days by air to the Cambodia gateway, before clearance and the same-day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Which port or airport does cargo for Phnom Penh clear through?

Cargo for Phnom Penh is routed via PNH air / Phnom Penh river port. Sea gateways for Cambodia are Sihanoukville Autonomous Port, Phnom Penh Autonomous Port (river); air gateways are PNH (Phnom Penh), REP (Siem Reap). We pick whichever gives the shortest total door time for your address.

How is the chargeable weight calculated for Phnom Penh?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Cambodia duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by General Department of Customs and Excise (GDCE) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

If this is your first shipment into Cambodia, the [Cambodia Country Commercial Guide](#) covers the practical import environment in more depth than a rate page reasonably can, and it is written by a party with no stake in your booking.
