China → Punta Cana · via PUJ air / Caucedo sea · clearance by Dirección General de Aduanas (DGA)



Cargo handling on the China-Punta Cana lane.

We move freight cargo from South China into Punta Cana through PUJ air / Caucedo sea. Punta Cana is resort corridor with heavy hospitality supply demand, which shapes the kind of cargo that moves on this lane and how it should be packed.

On the destination side, Dirección General de Aduanas (DGA) handles clearance; budget 3-8 days of dwell before the cargo is released.

What you will pay on arrival in Dominican Republic

Imports into Dominican Republic are cleared by Dirección General de Aduanas (DGA). The headline position is: ITBIS 18%; duty 0-20%, plus selective consumption tax on some categories. The de-minimis threshold is USD 200 for courier consignments.

Conformity is the part most first-time importers underestimate: Health registration for food, cosmetics and devices; INDOCAL conformity for regulated goods. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Dominican Republic: Free-zone versus ordinary import changes duty entirely. Health registration is required for regulated consumer goods. Tourism-driven demand peaks ahead of the winter season.

How this lane actually runs

Caucedo is a modern DP World terminal and one of the better-run gateways in the Caribbean, with direct and transshipped Asian services. The country's free-zone sector is large and its duty treatment differs sharply from ordinary import, so establish which regime the consignee operates under before quoting.

Before you book: Punta Cana checklist

- Ask for the HS code in writing from your supplier and verify the Dominican Republic duty rate against it yourself.
- Put the Punta Cana delivery address, contact name and phone number on the invoice, not just the packing list.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Get the conformity paperwork moving early: Health registration for food, cosmetics and devices; INDOCAL conformity for regulated goods.
- Budget for the inland leg: +1 day beyond gateway clearance to reach Punta Cana.

Frequently asked questions

How long does shipping from China to Punta Cana take?

China to the Dominican Republic gateway is 4–6 business days by air, 26–34 calendar days by sea. On top of that, allow 3–8 days of clearance with Dirección General de Aduanas (DGA) and a +1 day inland leg to Punta Cana.

What duty and tax will I pay importing into Punta Cana?

Dirección General de Aduanas (DGA) applies: ITBIS 18%; duty 0–20%, plus selective consumption tax on some categories. The de-minimis position is USD 200 for courier consignments. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Punta Cana.

What documents does Dirección General de Aduanas (DGA) require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Health registration for food, cosmetics and devices; INDOCAL conformity for regulated goods). We prepare and file these as part of the service.

How is the chargeable weight calculated for Punta Cana?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Which port or airport does cargo for Punta Cana clear through?

Cargo for Punta Cana is routed via PUJ air / Caucedo sea. Sea gateways for Dominican Republic are Caucedo (DP World), Haina, Puerto Plata; air gateways are SDQ (Santo Domingo), STI (Santiago), PUJ (Punta Cana). We pick whichever gives the shortest total door time for your address.

Is sea freight cheaper than air freight into Punta Cana?

Per kilo, yes — usually by a wide margin. The trade-off is time: 26–34 calendar days by sea versus 4–6 business days by air to the Dominican Republic gateway, before clearance and the +1 day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Dominican Republic duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Dirección General de Aduanas (DGA) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

For a wider view of how importing into Dominican Republic actually works — documentation norms, inspection behavior, the paperwork that tends to hold shipments — the [U.S. ITA guide to Dominican Republic customs regulations](#) is a useful independent read alongside our own lane notes.
