China → Cairo · via CAI air / Alexandria sea · clearance by Egyptian Customs Authority

Cairo is capital and the largest market in the Arab world, and it is served through CAI air / Alexandria sea. That combination is what actually sets your delivery date on this lane — allow +1 day for the inland leg on top of clearance.

On the destination side, Egyptian Customs Authority handles clearance; budget 7–15 days of dwell before the cargo is released.

Duty, tax and clearance into Cairo

Egyptian Customs Authority assesses duty and tax on cargo arriving for Cairo consignees. Current regime: VAT 14%; duty 0–60% depending on commodity, plus development fees on some categories, with a de-minimis position of No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: ACID number issued through the Nafeza single window before shipment — mandatory; GOEIC registration of the foreign factory for many consumer goods. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Egypt: ACID/Nafeza registration must be completed pre-shipment — this is the single most common cause of rejected cargo. GOEIC registration of the exporting factory is required for a long list of consumer goods. Letters of credit are required for many commercial imports.

What the routing looks like in practice

Egypt's Advance Cargo Information system is the decisive requirement on this lane: the importer must obtain an ACID number through Nafeza and the exporter must reference it on the shipping documents before the goods leave China. Cargo arriving without a valid ACID is refused entry. On top of that, GOEIC factory registration is required for many consumer categories and takes months to obtain.

Before you book: Cairo checklist

- Ask for the HS code in writing from your supplier and verify the Egypt duty rate against it yourself.
- Get the conformity paperwork moving early: ACID number issued through the Nafeza single window before shipment — mandatory; GOEIC registration of the foreign factory for many consumer goods.
- Check the de-minimis position (No practical de-minimis for commercial cargo) against your invoice value before you decide how to split the shipment.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Put the Cairo delivery address, contact name and phone number on the invoice, not just the packing list.

Frequently asked questions

How long does shipping from China to Cairo take?

China to the Egypt gateway is 4–7 business days by air, 20–28 calendar days by sea. On top of that, allow 7–15 days of clearance with Egyptian Customs Authority and a +1 day inland leg to Cairo.

What duty and tax will I pay importing into Cairo?

Egyptian Customs Authority applies: VAT 14%; duty 0–60% depending on commodity, plus development fees on some categories. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Cairo.

What certification do I need for Egypt?

For regulated goods, plan for: ACID number issued through the Nafeza single window before shipment — mandatory; GOEIC registration of the foreign factory for many consumer goods. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Can you ship batteries or sensitive cargo to Cairo?

Yes. Battery cargo by air follows IATA PI 965–970 depending on how the cells are packed, and moves on certified channels via CAI (Cairo), HRG (Hurghada), ALY (Alexandria). Surcharges apply and the declaration has to be made before booking.

Which port or airport does cargo for Cairo clear through?

Cargo for Cairo is routed via CAI air / Alexandria sea. Sea gateways for Egypt are Alexandria, Damietta, Port Said; air gateways are CAI (Cairo), HRG (Hurghada), ALY (Alexandria). We pick whichever gives the shortest total door time for your address.

How is the chargeable weight calculated for Cairo?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Egypt duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Egyptian Customs Authority against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Classification drives everything downstream: the same carton can attract very different duty depending on the heading it lands in, and the structure those headings come from is [the World Customs Organization Harmonized System](#). If your product sits near a boundary between two headings, resolve it before shipping rather than at the border.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

For a wider view of how importing into Egypt actually works — documentation norms, inspection behavior, the paperwork that tends to hold shipments — the [U.S. ITA guide to Egypt customs regulations](#) is a useful independent read alongside our own lane notes.
