

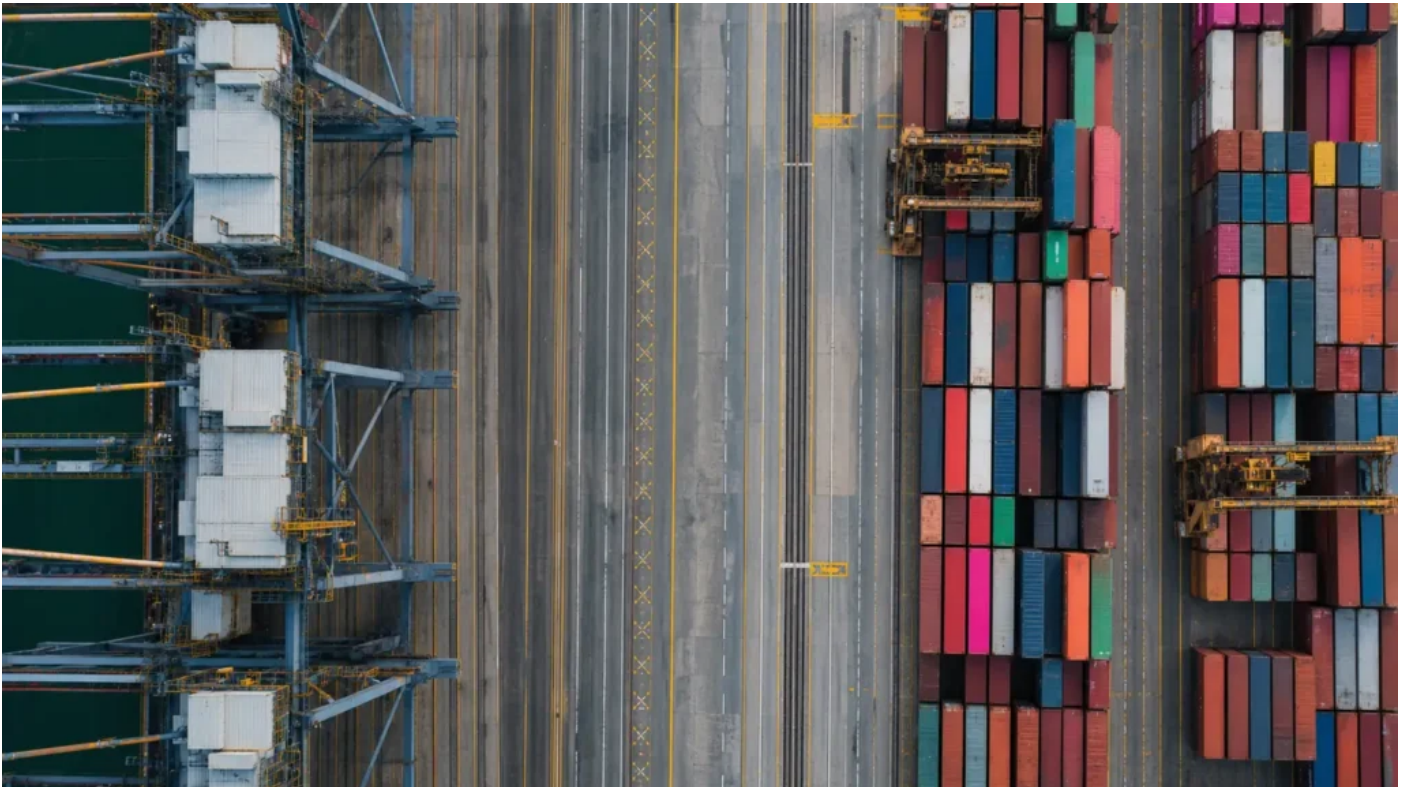

China → Balikpapan · via BPN air / Semayang sea · clearance by Directorate General of Customs and Excise (Bea Cukai)

Balikpapan is Kalimantan energy and mining service city, and it is served through BPN air / Semayang sea. That combination is what actually sets your delivery date on this lane — allow +2 days for the inland leg on top of clearance.

The clearing authority is Directorate General of Customs and Excise (Bea Cukai). Historical dwell on this gateway is around 4–10 days, and it lengthens in Sep–Nov.

Duty, tax and clearance into Balikpapan

Directorate General of Customs and Excise (Bea Cukai) assesses duty and tax on cargo arriving for Balikpapan consignees. Current regime: VAT 11%; duty 0–150%, with a 7.5% flat rate applied to many consumer parcels, plus income-tax prepayment (PPh) of

0.5–10%, with a de-minimis position of USD 3 FOB — one of the lowest thresholds in the world.

Conformity is the part most first-time importers underestimate: SNI mandatory standard for a long list of products; import license (API-U/API-P) held by the consignee; Permendag restricted-goods rules for textiles, footwear, electronics and toys. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Indonesia: Goods on the IRTAS restricted list need a license issued before the vessel arrives; retro-fixing after arrival is expensive. Used goods are broadly banned. Cosmetics and food need BPOM registration held locally.

Routing and transit on this lane

Indonesia is the most paperwork-heavy market in ASEAN. The USD 3 de-minimis means practically every shipment is dutiable, and Permendag import restrictions cover exactly the categories most China buyers ship — textiles, footwear, electronics, toys and cosmetics. Plan the license position before booking, not after arrival.

Before you book: Balikpapan checklist

- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Get the conformity paperwork moving early: SNI mandatory standard for a long list of products; import license (API-U/API-P) held by the consignee; Permendag restricted-goods rules for textiles, footwear, electronics and toys.
- Plan around the China-side windows too: Chinese New Year and Golden Week both compress capacity on the Indonesia lane.
- Confirm the consignee in Balikpapan can act as importer of record — Directorate General of Customs and Excise (Bea Cukai) will not release cargo to an unregistered party.
- Ask for the HS code in writing from your supplier and verify the Indonesia duty rate against it yourself.

Frequently asked questions

How long does shipping from China to Balikpapan take?

China to the Indonesia gateway is 6–11 calendar days. On top of that, allow 4–10 days of clearance with Directorate General of Customs and Excise (Bea Cukai) and a +2 days inland leg to Balikpapan.

What duty and tax will I pay importing into Balikpapan?

Directorate General of Customs and Excise (Bea Cukai) applies: VAT 11%; duty 0–150%, with a 7.5% flat rate applied to many consumer parcels, plus income-tax prepayment (PPH) of 0.5–10%. The de-minimis position is USD 3 FOB — one of the lowest thresholds in the world. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Balikpapan.

What certification do I need for Indonesia?

For regulated goods, plan for: SNI mandatory standard for a long list of products; import license (API-U/API-P) held by the consignee; Permendag restricted-goods rules for textiles, footwear, electronics and toys. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

What documents does Directorate General of Customs and Excise (Bea Cukai) require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (SNI mandatory standard for a long list of products; import license (API-U/API-P) held by the consignee; Permendag restricted-goods rules for textiles, footwear, electronics and toys). We prepare and file these as part of the service.

Which port or airport does cargo for Balikpapan clear through?

Cargo for Balikpapan is routed via BPN air / Semayang sea. Sea gateways for Indonesia are Tanjung Priok (Jakarta), Tanjung Perak (Surabaya), Belawan (Medan); air gateways are CGK (Jakarta), SUB (Surabaya), DPS (Denpasar). We pick whichever gives the shortest total door time for your address.

When is the busiest time on the China-Indonesia lane?

Space and rates tighten around Sep-Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

Checking the Indonesia duty position yourself

We publish these figures so you can budget, but the assessment that binds is the one [Indonesian Directorate General of Customs and Excise](#) makes on your declaration. Where a shipment is large enough that a percentage point matters, check their current tariff guidance rather than ours.

Classification drives everything downstream: the same carton can attract very different duty depending on the heading it lands in, and the structure those headings come from is [the World Customs Organization Harmonized System](#). If your product sits near a boundary between two headings, resolve it before shipping rather than at the border.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about

them after the container is packed.
