China → Jalal-Abad · via OSS air / Irkeshtam road · clearance by State Customs Service (EAEU member)

We move freight cargo from South China into Jalal-Abad through OSS air / Irkeshtam road. Jalal-Abad is southern regional center, which shapes the kind of cargo that moves on this lane and how it should be packed.

The clearing authority is State Customs Service (EAEU member). Historical dwell on this gateway is around 3–7 days, and it lengthens in Sep–Nov.

What you will pay on arrival in Kyrgyzstan

Imports into Kyrgyzstan are cleared by State Customs Service (EAEU member). The headline position is: VAT 12%; EAEU common external tariff. The de-minimis threshold is EUR 200 for personal parcels under EAEU rules.

Conformity is the part most first-time importers underestimate: EAC conformity mark. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Kyrgyzstan: Torugart and Irkeshtam have seasonal closures and limited operating hours. EAC certification applies as an EAEU member. Onward movement into Kazakhstan or Russia is duty-free within the union but still requires correct origin documentation.

How this lane actually runs

Kyrgyzstan is served by direct trucking from Kashgar over the Irkeshtam and Torugart passes — a genuinely short lane that can beat rail on time. Bishkek's Dordoi market has historically been a redistribution point for Chinese goods across Central Asia, so consolidated LCL is well developed here. Both passes are altitude crossings and close in bad winter weather.

Pre-shipment checklist for Jalal-Abad

- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Put the Jalal-Abad delivery address, contact name and phone number on the invoice, not just the packing list.
- Confirm the consignee in Jalal-Abad can act as importer of record — State Customs Service (EAEU member) will not release cargo to an unregistered party.
- Budget for the inland leg: +1 day beyond gateway clearance to reach Jalal-Abad.

Frequently asked questions

How long does shipping from China to Jalal-Abad take?

China to the Kyrgyzstan gateway is 3–5 business days by air, 10–16 calendar days by road from Kashgar by sea. On top of that, allow 3–7 days of clearance with State Customs Service (EAEU member) and a +1 day inland leg to Jalal-Abad.

What duty and tax will I pay importing into Jalal-Abad?

State Customs Service (EAEU member) applies: VAT 12%; EAEU common external tariff. The de-minimis position is EUR 200 for personal parcels under EAEU rules. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Jalal-Abad.

Can you ship batteries or sensitive cargo to Jalal-Abad?

Yes. Battery cargo by air follows IATA PI 965–970 depending on how the cells are packed, and moves on certified channels via FRU (Bishkek Manas), OSS (Osh). Surcharges apply and the declaration has to be made before booking.

When is the busiest time on the China–Kyrgyzstan lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

Which port or airport does cargo for Jalal-Abad clear through?

Cargo for Jalal-Abad is routed via OSS air / Irkeshtam road. Sea gateways for Kyrgyzstan are Landlocked — road via the Irkeshtam and Torugart crossings from Kashgar; air gateways are FRU (Bishkek Manas), OSS (Osh). We pick whichever gives the shortest total door time for your address.

Is sea freight cheaper than air freight into Jalal-Abad?

Per kilo, yes — usually by a wide margin. The trade-off is time: 10–16 calendar days by road from Kashgar by sea versus 3–5 business days by air to the Kyrgyzstan gateway, before clearance and the +1 day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Kyrgyzstan duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by State Customs Service (EAEU member) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC](#)

[Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
