China → Osh · via OSS air / Irkeshtam road · clearance by State Customs Service (EAEU member)

Osh is southern city closest to the China crossings, and it is served through OSS air / Irkeshtam road. That combination is what actually sets your delivery date on this lane — the inland leg is same-day, so the clearance date is effectively the delivery date.

The clearing authority is State Customs Service (EAEU member). Historical dwell on this gateway is around 3–7 days, and it lengthens in Sep–Nov.

Duty, tax and clearance into Osh

State Customs Service (EAEU member) assesses duty and tax on cargo arriving for Osh consignees. Current regime: VAT 12%; EAEU common external tariff, with a de-minimis position of EUR 200 for personal parcels under EAEU rules.

Conformity is the part most first-time importers underestimate: EAC conformity mark. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Kyrgyzstan: Torugart and Irkeshtam have seasonal closures and limited operating hours. EAC certification applies as an EAEU member. Onward movement into Kazakhstan or Russia is duty-free within the union but still requires correct origin documentation.

What the routing looks like in practice

Kyrgyzstan is served by direct trucking from Kashgar over the Irkeshtam and Torugart passes — a genuinely short lane that can beat rail on time. Bishkek's Dordoi market has historically been a redistribution point for Chinese goods across Central Asia, so consolidated LCL is well developed here. Both passes are altitude crossings and close in bad winter weather.

Before you book: Osh checklist

- Confirm the consignee in Osh can act as importer of record — State Customs Service (EAEU member) will not release cargo to an unregistered party.
- Ask for the HS code in writing from your supplier and verify the Kyrgyzstan duty rate against it yourself.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.

Frequently asked questions

How long does shipping from China to Osh take?

China to the Kyrgyzstan gateway is 3–5 business days. On top of that, allow 3–7 days of clearance with State Customs Service (EAEU member) and a same-day inland leg to Osh.

What duty and tax will I pay importing into Osh?

State Customs Service (EAEU member) applies: VAT 12%; EAEU common external tariff. The de-minimis position is EUR 200 for personal parcels under EAEU rules. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Osh.

Which port or airport does cargo for Osh clear through?

Cargo for Osh is routed via OSS air / Irkeshtam road. Sea gateways for Kyrgyzstan are Landlocked — road via the Irkeshtam and Torugart crossings from Kashgar; air gateways are FRU (Bishkek Manas), OSS (Osh). We pick whichever gives the shortest total door time for your address.

What documents does State Customs Service (EAEU member) require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (EAC conformity mark). We prepare and file these as part of the service.

What certification do I need for Kyrgyzstan?

For regulated goods, plan for: EAC conformity mark. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

How is the chargeable weight calculated for Osh?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Kyrgyzstan duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by State Customs Service (EAEU member) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

On the air side, anything with a cell or a battery in it, plus liquids, powders, magnets and aerosols, is governed by [the IATA Dangerous Goods Regulations](#). Those articles are not refused outright, but they need to be declared at booking so the shipment is built correctly — declaring them late is the single most common cause of an air consignment being offloaded.
