China → Kiffa · via NKC air / Nouakchott sea · clearance by Direction Générale des Douanes de Mauritanie

For buyers shipping into Kiffa, the practical question is not the ocean or flight time but what happens after arrival. Kiffa is interior regional center; cargo enters through NKC air / Nouakchott sea, and allow +2 days for the inland leg on top of clearance.

The clearing authority is Direction Générale des Douanes de Mauritanie. Historical dwell on this gateway is around 7-15 days, and it lengthens in Sep-Nov.

What the routing looks like in practice

Nouakchott's Port de l'Amitié handles most general cargo, with Nouadhibou serving the mining and fishing sectors. Asian cargo generally transships through Las Palmas, Algeciras or Casablanca, so feeder frequency rather than mainline transit determines the

arrival window.

Duty, tax and clearance into Kiffa

Direction Générale des Douanes de Mauritanie assesses duty and tax on cargo arriving for Kiffa consignees. Current regime: VAT 16%; duty 0–20%, plus statistical fee, with a de-minimis position of No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Certificate of conformity for regulated goods; import declaration through the customs single window. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Mauritania: Transshipment dependency means feeder scheduling drives transit. Mining-sector project cargo may qualify for exemption tied to the concession. Confirm the consignee's import registration.

Mode	Transit to gateway	Best suited to
➔ Air Freight	6-9 business days	time-critical, high-value and low-volume cargo
🚢 Sea Freight	28-38 calendar days	volume cargo where cost per kilo matters more than speed

Transit shown is China departure to the Mauritania gateway and excludes the +2 days inland leg to Kiffa and 7-15 days of clearance.

What to sort out before the cargo leaves China

- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Compare gross weight against volumetric weight (L×W×H ÷ 6000) — the higher figure is what gets billed on air and express.
- Check the de-minimis position (No practical de-minimis for commercial cargo) against your invoice value before you decide how to split the shipment.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Get the conformity paperwork moving early: Certificate of conformity for regulated goods; import declaration through the customs single window.
- Confirm the consignee in Kiffa can act as importer of record — Direction Générale des Douanes de Mauritanie will not release cargo to an unregistered party.

Frequently asked questions

How long does shipping from China to Kiffa take?

China to the Mauritania gateway is 6–9 business days by air, 28–38 calendar days by sea. On top of that, allow 7–15 days of clearance with Direction Générale des Douanes de Mauritanie and a +2 days inland leg to Kiffa.

What duty and tax will I pay importing into Kiffa?

Direction Générale des Douanes de Mauritanie applies: VAT 16%; duty 0–20%, plus statistical fee. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Kiffa.

Can you deliver door-to-door in Kiffa?

Yes. Delivery to a Kiffa address is quoted as one figure covering freight, duty and tax owed to Direction Générale des Douanes de Mauritanie, and the +2 days inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

Can you ship batteries or sensitive cargo to Kiffa?

Yes. Battery cargo by air follows IATA PI 965–970 depending on how the cells are packed, and moves on certified channels via NKC (Nouakchott Oumtounsy). Surcharges apply and the declaration has to be made before booking.

How is the chargeable weight calculated for Kiffa?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

What documents does Direction Générale des Douanes de Mauritanie require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Certificate of conformity for regulated goods; import declaration through the customs single window). We prepare and file these as part of the service.

Checking the Mauritania duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Direction Générale des Douanes de Mauritanie against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.
