China → Kiffa · via NKC air / Nouakchott sea · clearance by Direction Générale des Douanes de Mauritanie

Freight from China into Kiffa clears through NKC air / Nouakchott sea. Kiffa is interior regional center, and allow +2 days for the inland leg on top of clearance.

On the destination side, Direction Générale des Douanes de Mauritanie handles clearance; budget 7-15 days of dwell before the cargo is released.

What you will pay on arrival in Mauritania

Imports into Mauritania are cleared by Direction Générale des Douanes de Mauritanie. The headline position is: VAT 16%; duty 0-20%, plus statistical fee. The de-minimis threshold is No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Certificate of conformity for regulated goods; import declaration through the customs single window. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Mauritania: Transshipment dependency means feeder scheduling drives transit. Mining-sector project cargo may qualify for exemption tied to the concession. Confirm the consignee's import registration.

What the routing looks like in practice

Nouakchott's Port de l'Amitié handles most general cargo, with Nouadhibou serving the mining and fishing sectors. Asian cargo generally transships through Las Palmas, Algeciras or Casablanca, so feeder frequency rather than mainline transit determines the arrival window.

What to sort out before the cargo leaves China

- Put the Kiffa delivery address, contact name and phone number on the invoice, not just the packing list.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Get the conformity paperwork moving early: Certificate of conformity for regulated goods; import declaration through the customs single window.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Plan around the China-side windows too: Chinese New Year and Golden Week both compress capacity on the Mauritania lane.
- Budget for the inland leg: +2 days beyond gateway clearance to reach Kiffa.

Frequently asked questions

How long does shipping from China to Kiffa take?

China to the Mauritania gateway is 28–38 calendar days. On top of that, allow 7–15 days of clearance with Direction Générale des Douanes de Mauritanie and a +2 days inland leg to Kiffa.

What duty and tax will I pay importing into Kiffa?

Direction Générale des Douanes de Mauritanie applies: VAT 16%; duty 0–20%, plus statistical fee. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Kiffa.

Which port or airport does cargo for Kiffa clear through?

Cargo for Kiffa is routed via NKC air / Nouakchott sea. Sea gateways for Mauritania are Nouakchott (Port de l'Amitié), Nouadhibou; air gateways are NKC (Nouakchott Oumtounsy). We pick whichever gives the shortest total door time for your address.

What certification do I need for Mauritania?

For regulated goods, plan for: Certificate of conformity for regulated goods; import declaration through the customs single window. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Can you deliver door-to-door in Kiffa?

Yes. Delivery to a Kiffa address is quoted as one figure covering freight, duty and tax owed to Direction Générale des Douanes de Mauritanie, and the +2 days inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

How is the chargeable weight calculated for Kiffa?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Mauritania duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Direction Générale des Douanes de Mauritanie against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.

Get a rate for Kiffa
