China → Rosso · via NKC air / Nouakchott sea · clearance by Direction Générale des Douanes de Mauritanie

We move sea freight cargo from South China into Rosso through NKC air / Nouakchott sea. Rosso is southern river border town, which shapes the kind of cargo that moves on this lane and how it should be packed.

The clearing authority is Direction Générale des Douanes de Mauritanie. Historical dwell on this gateway is around 7-15 days, and it lengthens in Sep-Nov.

What the routing looks like in practice

Nouakchott's Port de l'Amitié handles most general cargo, with Nouadhibou serving the mining and fishing sectors. Asian cargo generally transships through Las Palmas, Algeciras or Casablanca, so feeder frequency rather than mainline transit determines the arrival window.

Import duty and tax position for Rosso

Imports into Mauritania are cleared by Direction Générale des Douanes de Mauritanie. The headline position is: VAT 16%; duty 0-20%, plus statistical fee. The de-minimis threshold is No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Certificate of conformity for regulated goods; import declaration through the customs single window. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Mauritania: Transshipment dependency means feeder scheduling drives transit. Mining-sector project cargo may qualify for exemption tied to the concession. Confirm the consignee's import registration.

What to sort out before the cargo leaves China

- Budget for the inland leg: +1 day beyond gateway clearance to reach Rosso.
- Ask for the HS code in writing from your supplier and verify the Mauritania duty rate against it yourself.
- Check the de-minimis position (No practical de-minimis for commercial cargo) against your invoice value before you decide how to split the shipment.
- Plan around the China-side windows too: Chinese New Year and Golden Week both compress capacity on the Mauritania lane.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.

Frequently asked questions

How long does shipping from China to Rosso take?

China to the Mauritania gateway is 28–38 calendar days. On top of that, allow 7–15 days of clearance with Direction Générale des Douanes de Mauritanie and a +1 day inland leg to Rosso.

What duty and tax will I pay importing into Rosso?

Direction Générale des Douanes de Mauritanie applies: VAT 16%; duty 0–20%, plus statistical fee. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Rosso.

Can you deliver door-to-door in Rosso?

Yes. Delivery to a Rosso address is quoted as one figure covering freight, duty and tax owed to Direction Générale des Douanes de Mauritanie, and the +1 day inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

When is the busiest time on the China–Mauritania lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

How is the chargeable weight calculated for Rosso?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Can you ship batteries or sensitive cargo to Rosso?

Yes. Battery cargo by sea moves under UN3480/UN3481 with an MSDS, and the dangerous-goods documentation is prepared as part of the booking into Nouakchott (Port de l'Amitié), Nouadhibou. Surcharges apply and space is more limited than for general cargo.

Checking the Mauritania duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Direction Générale des Douanes de Mauritanie against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
