Sea Freight

China → Prilep · via SKP air / Thessaloniki transit · clearance by Customs Administration of North Macedonia

We move sea freight cargo from South China into Prilep through SKP air / Thessaloniki transit. Prilep is central manufacturing center, which shapes the kind of cargo that moves on this lane and how it should be packed.

On the destination side, Customs Administration of North Macedonia handles clearance; budget 3-8 days of dwell before the cargo is released.

Import duty and tax position for Prilep

Imports into North Macedonia are cleared by Customs Administration of North Macedonia. The headline position is: VAT 18%; customs duty 0-20%. The de-minimis threshold is EUR 45 for personal consignments.

Conformity is the part most first-time importers underestimate: Technical regulations aligned to EU rules for most product groups. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for North Macedonia: Greek or Albanian transit documentation is required. Free economic zones near Skopje offer duty relief for qualifying manufacturing inputs.

Routing and transit on this lane

Thessaloniki is the shortest sea gateway — roughly a half-day road leg to Skopje — which makes North Macedonia one of the easier landlocked Balkan markets to serve. Durrës in Albania is the alternative when Greek capacity tightens.

Pre-shipment checklist for Prilep

- Confirm the consignee in Prilep can act as importer of record — Customs Administration of North Macedonia will not release cargo to an unregistered party.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Get the conformity paperwork moving early: Technical regulations aligned to EU rules for most product groups.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.

Frequently asked questions

How long does shipping from China to Prilep take?

China to the North Macedonia gateway is 26–34 calendar days plus inland leg. On top of that, allow 3–8 days of clearance with Customs Administration of North Macedonia and a +1 day inland leg to Prilep.

What duty and tax will I pay importing into Prilep?

Customs Administration of North Macedonia applies: VAT 18%; customs duty 0–20%. The de-minimis position is EUR 45 for personal consignments. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Prilep.

What documents does Customs Administration of North Macedonia require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Technical regulations aligned to EU rules for most product groups). We prepare and file these as part of the service.

What certification do I need for North Macedonia?

For regulated goods, plan for: Technical regulations aligned to EU rules for most product groups. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

When is the busiest time on the China–North Macedonia lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

How is the chargeable weight calculated for Prilep?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the North Macedonia duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Customs Administration of North Macedonia against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.
