China → Sur · via MCT air / Sohar sea · clearance by Directorate General of Customs, Royal Oman Police

We move sea freight cargo from South China into Sur through MCT air / Sohar sea. Sur is eastern coastal town, which shapes the kind of cargo that moves on this lane and how it should be packed.

Clearance itself is handled by Directorate General of Customs, Royal Oman Police, and typical dwell at the gateway runs 2–5 days.

Routing and transit on this lane

Salalah sits directly on the main Asia–Europe trunk route, which makes it one of the faster Gulf destinations from South China, and Sohar serves the industrial north. Oman is also a practical alternative gateway when Jebel Ali is congested, with road onward

delivery into the UAE.

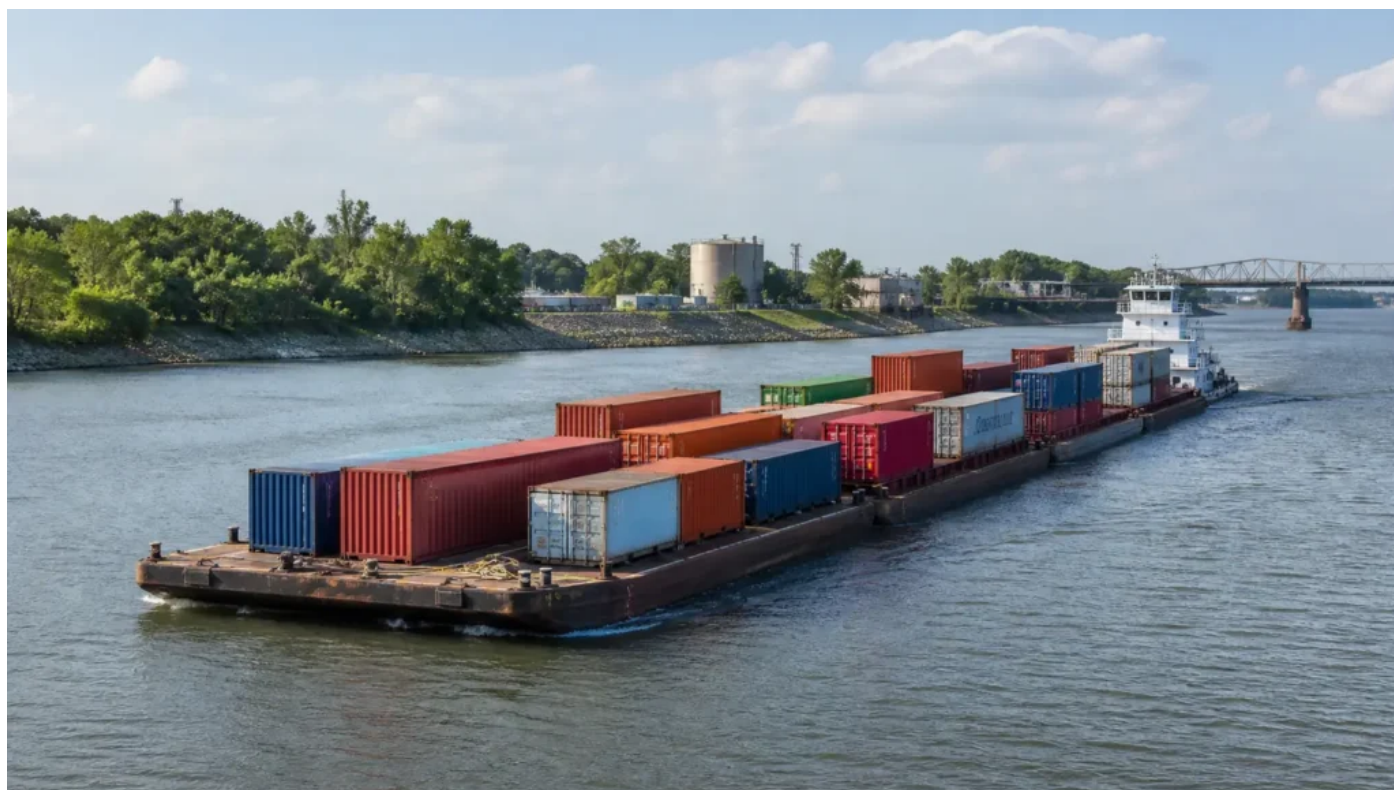

Duty, tax and clearance into Sur

Imports into Oman are cleared by Directorate General of Customs, Royal Oman Police. The headline position is: VAT 5%; GCC common tariff of 5% on most goods. The de-minimis threshold is OMR 100 for personal consignments.

Conformity is the part most first-time importers underestimate: Omani conformity certificate for regulated goods; Arabic labeling for consumer products. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Oman: Alcohol and pork are restricted to licensed importers. Arabic labeling is required. Some industrial goods need ministry approval tied to the project.

What to sort out before the cargo leaves China

- Check the de-minimis position (OMR 100 for personal consignments) against your invoice value before you decide how to split the shipment.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Budget for the inland leg: +1 day beyond gateway clearance to reach Sur.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.

Frequently asked questions

How long does shipping from China to Sur take?

China to the Oman gateway is 14–20 calendar days. On top of that, allow 2–5 days of clearance with Directorate General of Customs, Royal Oman Police and a +1 day inland leg to Sur.

What duty and tax will I pay importing into Sur?

Directorate General of Customs, Royal Oman Police applies: VAT 5%; GCC common tariff of 5% on most goods. The de-minimis position is OMR 100 for personal consignments. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Sur.

When is the busiest time on the China–Oman lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

Which port or airport does cargo for Sur clear through?

Cargo for Sur is routed via MCT air / Sohar sea. Sea gateways for Oman are Sohar, Salalah, Duqm; air gateways are MCT (Muscat), SLL (Salalah). We pick whichever gives the shortest total door time for your address.

Can you ship batteries or sensitive cargo to Sur?

Yes. Battery cargo by sea moves under UN3480/UN3481 with an MSDS, and the dangerous-goods documentation is prepared as part of the booking into Sohar, Salalah, Duqm. Surcharges apply and space is more limited than for general cargo.

How is the chargeable weight calculated for Sur?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Oman duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Directorate General of Customs, Royal Oman Police against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.

If this is your first shipment into Oman, the [Oman Country Commercial Guide](#) covers the practical import environment in more depth than a rate page reasonably can, and it is written by a party with no stake in your booking.
