China → Chancay · via LIM air / Chancay sea · clearance by SUNAT — Superintendencia Nacional de Aduanas

Freight from China into Chancay clears through LIM air / Chancay sea. Chancay is the new deepwater megaport north of Lima, and the inland leg is same-day, so the clearance date is effectively the delivery date.

Clearance itself is handled by SUNAT — Superintendencia Nacional de Aduanas, and typical dwell at the gateway runs 3–8 days.

Import duty and tax position for Chancay

Imports into Peru are cleared by SUNAT — Superintendencia Nacional de Aduanas. The headline position is: IGV 18%; duty 0–11%, with 0% on most goods under the China–Peru free trade agreement. The de-minimis threshold is USD 200 for courier consignments.

Conformity is the part most first-time importers underestimate: Certificate of origin for FTA preference; DIGEMID or DIGESA registration for health and food products. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Peru: FTA preference requires a valid certificate of origin. Health, food and cosmetic products need consignee-side registration before arrival. Chancay's inland connections are still maturing — confirm the final trucking arrangement.

What the routing looks like in practice

The Chancay megaport opened in late 2024 and created the first direct Shanghai-South America service, cutting roughly a week off the traditional Callao routing that transships in Mexico or Panama. For cargo destined to Lima it is now worth quoting Chancay and Callao separately — the difference in transit is material, and Chancay is positioning itself as a redistribution hub for the whole west coast.

Pre-shipment checklist for Chancay

- Confirm the consignee in Chancay can act as importer of record — SUNAT — Superintendencia Nacional de Aduanas will not release cargo to an unregistered party.
- Get the conformity paperwork moving early: Certificate of origin for FTA preference; DIGEMID or DIGESA registration for health and food products.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.
- Put the Chancay delivery address, contact name and phone number on the invoice, not just the packing list.

Frequently asked questions

How long does shipping from China to Chancay take?

China to the Peru gateway is 22-30 calendar days to Chancay, 26-34 to Callao. On top of that, allow 3-8 days of clearance with SUNAT — Superintendencia Nacional de Aduanas and a same-day inland leg to Chancay.

What duty and tax will I pay importing into Chancay?

SUNAT — Superintendencia Nacional de Aduanas applies: IGV 18%; duty 0-11%, with 0% on most goods under the China-Peru free trade agreement. The de-minimis position is USD 200 for courier consignments. Under a DDP arrangement these are pre-paid, so

nothing is collected on arrival in Chancay.

What certification do I need for Peru?

For regulated goods, plan for: Certificate of origin for FTA preference; DIGEMID or DIGESA registration for health and food products. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Can you ship batteries or sensitive cargo to Chancay?

Yes. Battery cargo by sea moves under UN3480/UN3481 with an MSDS, and the dangerous-goods documentation is prepared as part of the booking into Callao, Chancay, Paita. Surcharges apply and space is more limited than for general cargo.

Which port or airport does cargo for Chancay clear through?

Cargo for Chancay is routed via LIM air / Chancay sea. Sea gateways for Peru are Callao, Chancay, Paita; air gateways are LIM (Lima Jorge Chávez). We pick whichever gives the shortest total door time for your address.

What documents does SUNAT — Superintendencia Nacional de Aduanas require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Certificate of origin for FTA preference; DIGEMID or DIGESA registration for health and food products). We prepare and file these as part of the service.

Checking the Peru duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by SUNAT — Superintendencia Nacional de Aduanas against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

For a wider view of how importing into Peru actually works — documentation norms, inspection behavior, the paperwork that tends to hold shipments — the [U.S. ITA guide to Peru customs regulations](#) is a useful independent read alongside our own lane notes.
