China → Le Tampon · via RUN air / Port Reunion sea · clearance by Douane française (EU customs territory)



Cargo handling on the China-Le Tampon lane.

Freight from China into Le Tampon clears through RUN air / Port Reunion sea. Le Tampon is interior highland municipality, and allow +1 day for the inland leg on top of clearance.

The clearing authority is Douane française (EU customs territory). Historical dwell on this gateway is around 3–8 days, and it lengthens in Sep–Nov.

Import duty and tax position for Le Tampon

Imports into Reunion are cleared by Douane française (EU customs territory). The headline position is: Reduced VAT of 8.5% plus octroi de mer — a local dock due of 6.5–60% that is unique to the French overseas departments. The de-minimis threshold is EUR 150 for duty; VAT applies from the first euro.

Conformity is the part most first-time importers underestimate: CE marking under EU rules; French labeling requirements. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Reunion: Octroi de mer is the dominant cost element and varies by product and local production status. EU rules otherwise apply in full, including CE marking and French labeling.

What the routing looks like in practice

Réunion is part of the EU customs territory, so EU tariff and CE marking rules apply — but the octroi de mer dock due, which does not exist in mainland France, can add far more to landed cost than the customs duty itself. Its rate depends on whether an equivalent product is made locally, so classification research genuinely pays here.

What to sort out before the cargo leaves China

- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Get the conformity paperwork moving early: CE marking under EU rules; French labeling requirements.
- Check the de-minimis position (EUR 150 for duty; VAT applies from the first euro) against your invoice value before you decide how to split the shipment.
- Put the Le Tampon delivery address, contact name and phone number on the invoice, not just the packing list.
- Plan around the China-side windows too: Chinese New Year and Golden Week both compress capacity on the Reunion lane.
- Budget for the inland leg: +1 day beyond gateway clearance to reach Le Tampon.

Frequently asked questions

How long does shipping from China to Le Tampon take?

China to the Reunion gateway is 5–8 business days by air, 24–34 calendar days by sea. On top of that, allow 3–8 days of clearance with Douane française (EU customs territory) and a +1 day inland leg to Le Tampon.

What duty and tax will I pay importing into Le Tampon?

Douane française (EU customs territory) applies: Reduced VAT of 8.5% plus octroi de mer — a local dock due of 6.5–60% that is unique to the French overseas departments. The de-minimis position is EUR 150 for duty; VAT applies from the first euro. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Le Tampon.

Which port or airport does cargo for Le Tampon clear through?

Cargo for Le Tampon is routed via RUN air / Port Reunion sea. Sea gateways for Reunion are Port Réunion (Le Port); air gateways are RUN (Saint-Denis Roland Garros). We pick whichever gives the shortest total door time for your address.

How is the chargeable weight calculated for Le Tampon?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

What certification do I need for Reunion?

For regulated goods, plan for: CE marking under EU rules; French labeling requirements. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Is sea freight cheaper than air freight into Le Tampon?

Per kilo, yes — usually by a wide margin. The trade-off is time: 24–34 calendar days by sea versus 5–8 business days by air to the Reunion gateway, before clearance and the +1 day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Reunion duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Douane française (EU customs territory) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC](#)

[Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
