For buyers shipping into Krasnodar, the practical question is not the ocean or flight time but what happens after arrival. Krasnodar is southern agricultural and trade center; cargo enters through KRR air / Novorossiysk sea, and allow +1 day for the inland leg on top of clearance.

On the destination side, Federal Customs Service of Russia (EAEU regime) handles clearance; budget 3–10 days of dwell before the cargo is released.

Duty, tax and clearance into Krasnodar

Federal Customs Service of Russia (EAEU regime) assesses duty and tax on cargo arriving for Krasnodar consignees. Current regime: VAT 20%; EAEU common external tariff, typically 0–20%, plus recycling and excise levies on some categories, with a de-

minimis position of EUR 200 for personal parcels under EAEU rules.

Conformity is the part most first-time importers underestimate: EAC conformity mark valid across the Eurasian Economic Union; Russian-language labeling required. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Russia: Export-control and sanctions screening is essential — dual-use goods, electronics and machinery require careful classification and counterparty checks before shipment. EAC certification and Russian labeling are mandatory. Payment routing should be confirmed before booking.

What the routing looks like in practice

Russia is served three ways from China and the choice matters more here than anywhere else: Vladivostok by sea in under a week then rail west, direct block trains through Manzhouli or Zabaikalsk to Moscow in about 14–20 days, or the long Suez routing to St Petersburg. Rail and Far East capacity are both frequently oversubscribed, so book earlier than the transit time alone would suggest.

What to sort out before the cargo leaves China

- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Compare gross weight against volumetric weight (L×W×H ÷ 6000) — the higher figure is what gets billed on air and express.
- Put the Krasnodar delivery address, contact name and phone number on the invoice, not just the packing list.
- Ask for the HS code in writing from your supplier and verify the Russia duty rate against it yourself.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Plan around the China-side windows too: Chinese New Year and Golden Week both compress capacity on the Russia lane.

Frequently asked questions

How long does shipping from China to Krasnodar take?

China to the Russia gateway is 2–4 business days by air, Vladivostok 3–7 days; St Petersburg 40–55 days via Suez by sea. On top of that, allow 3–10 days of clearance with Federal Customs Service of Russia (EAEU regime) and a +1 day inland leg to Krasnodar.

What duty and tax will I pay importing into Krasnodar?

Federal Customs Service of Russia (EAEU regime) applies: VAT 20%; EAEU common external tariff, typically 0–20%, plus recycling and excise levies on some categories. The de-minimis position is EUR 200 for personal parcels under EAEU rules. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Krasnodar.

Which port or airport does cargo for Krasnodar clear through?

Cargo for Krasnodar is routed via KRR air / Novorossiysk sea. Sea gateways for Russia are Vladivostok, Vostochny, Novorossiysk; air gateways are SVO (Moscow Sheremetyevo), DME (Moscow Domodedovo), LED (St Petersburg). We pick whichever gives the shortest total door time for your address.

What certification do I need for Russia?

For regulated goods, plan for: EAC conformity mark valid across the Eurasian Economic Union; Russian-language labeling required. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

What documents does Federal Customs Service of Russia (EAEU regime) require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (EAC conformity mark valid across the Eurasian Economic Union; Russian-language labeling required). We prepare and file these as part of the service.

Is sea freight cheaper than air freight into Krasnodar?

Per kilo, yes — usually by a wide margin. The trade-off is time: Vladivostok 3–7 days; St Petersburg 40–55 days via Suez by sea versus 2–4 business days by air to the Russia gateway, before clearance and the +1 day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Russia duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Federal Customs Service of Russia (EAEU regime) against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Classification drives everything downstream: the same carton can attract very different duty depending on the heading it lands in, and the structure those headings come from is [the World Customs Organization Harmonized System](#). If your product sits near a boundary between two headings, resolve it before shipping rather than at the border.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.
