China → Honiara · via HIR air / Honiara sea · clearance by Solomon Islands Customs and Excise Division

For buyers shipping into Honiara, the practical question is not the ocean or flight time but what happens after arrival. Honiara is capital and the main port; cargo enters through HIR air / Honiara sea, and the inland leg is same-day, so the clearance date is effectively the delivery date.

On the destination side, Solomon Islands Customs and Excise Division handles clearance; budget 5-12 days of dwell before the cargo is released.

Import duty and tax position for Honiara

Solomon Islands Customs and Excise Division assesses duty and tax on cargo arriving for Honiara consignees. Current regime: GST 15%; duty 0-20% depending on commodity, with a de-minimis position of No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Biosecurity clearance; import permits for controlled goods. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Solomon Islands: Limited port capacity and berth congestion affect schedules. Inter-island delivery beyond Honiara is a separate arrangement. Biosecurity clearance required.

Routing and transit on this lane

Honiara is served by feeder from Brisbane, Port Moresby or Singapore. Port handling capacity is limited and berth availability, rather than sailing time, is often what delays cargo. Inter-island distribution beyond Honiara requires local coastal shipping and should be quoted separately.

What to sort out before the cargo leaves China

- Get the conformity paperwork moving early: Biosecurity clearance; import permits for controlled goods.
- Check the de-minimis position (No practical de-minimis for commercial cargo) against your invoice value before you decide how to split the shipment.
- Put the Honiara delivery address, contact name and phone number on the invoice, not just the packing list.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Ask for the HS code in writing from your supplier and verify the Solomon Islands duty rate against it yourself.

Frequently asked questions

How long does shipping from China to Honiara take?

China to the Solomon Islands gateway is 6–10 business days. On top of that, allow 5–12 days of clearance with Solomon Islands Customs and Excise Division and a same-day inland leg to Honiara.

What duty and tax will I pay importing into Honiara?

Solomon Islands Customs and Excise Division applies: GST 15%; duty 0–20% depending on commodity. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Honiara.

What certification do I need for Solomon Islands?

For regulated goods, plan for: Biosecurity clearance; import permits for controlled goods. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Can you deliver door-to-door in Honiara?

Yes. Delivery to a Honiara address is quoted as one figure covering freight, duty and tax owed to Solomon Islands Customs and Excise Division, and the same-day inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

Can you ship batteries or sensitive cargo to Honiara?

Yes. Battery cargo by air follows IATA PI 965–970 depending on how the cells are packed, and moves on certified channels via HIR (Honiara Henderson). Surcharges apply and the declaration has to be made before booking.

Is sea freight cheaper than air freight into Honiara?

Per kilo, yes — usually by a wide margin. The trade-off is time: 20–30 calendar days by sea versus 6–10 business days by air to the Solomon Islands gateway, before clearance and the same-day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Solomon Islands duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Solomon Islands Customs and Excise Division against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Most landed-cost surprises trace back to classification rather than freight. [the WCO Harmonized System](#) defines the heading structure every customs administration builds on, and [ITC Market Access Map](#) will show you the duty a given heading attracts in this destination.

On the air side, anything with a cell or a battery in it, plus liquids, powders, magnets and aerosols, is governed by [the IATA Dangerous Goods Regulations](#). Those articles are not refused outright, but they need to be declared at booking so the shipment is built correctly — declaring them late is the single most common cause of an air consignment being offloaded.
