We move freight cargo from South China into Keelung through Keelung sea. Keelung is northern port city with immediate quayside access, which shapes the kind of cargo that moves on this lane and how it should be packed.

The clearing authority is Customs Administration, Ministry of Finance. Historical dwell on this gateway is around 1-3 days, and it lengthens in Sep-Nov.

Duty, tax and clearance into Keelung

Imports into Taiwan are cleared by Customs Administration, Ministry of Finance. The headline position is: Business tax 5%; duty 0-30% depending on commodity. The de-minimis threshold is TWD 2,000, and only twice in any six-month window per consignee.

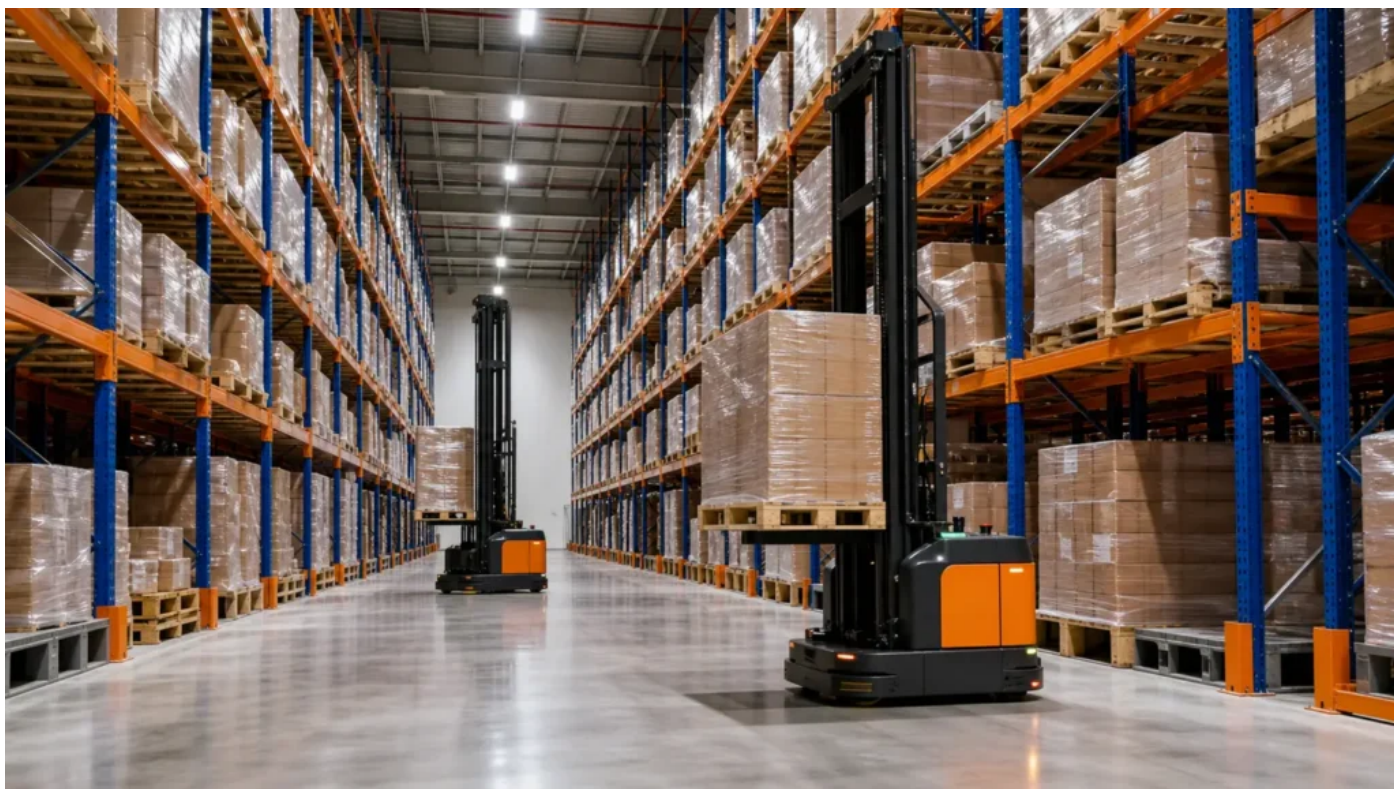
Conformity is the part most first-time importers underestimate: BSMI commodity inspection mark for electrical and consumer goods; NCC approval for radio devices. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Taiwan: Certain mainland-origin goods remain on Taiwan's restricted import list — check the commodity classification before booking. BSMI inspection applies to a wide range of consumer electronics and children's products.

How this lane actually runs

Taiwan is effectively an overnight air lane and a two-to-four-day sea lane from South China. The frequency-based de-minimis rule matters more than the value threshold: a consignee who receives more than two low-value parcels in six months loses the exemption entirely, which catches repeat e-commerce buyers.

What to sort out before the cargo leaves China

- Put the Keelung delivery address, contact name and phone number on the invoice, not just the packing list.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.
- Get the conformity paperwork moving early: BSMI commodity inspection mark for electrical and consumer goods; NCC approval for radio devices.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.

Frequently asked questions

How long does shipping from China to Keelung take?

China to the Taiwan gateway is 1-2 business days by air, 2-4 calendar days by sea. On top of that, allow 1-3 days of clearance with Customs Administration, Ministry of Finance and a same-day inland leg to Keelung.

What duty and tax will I pay importing into Keelung?

Customs Administration, Ministry of Finance applies: Business tax 5%; duty 0-30% depending on commodity. The de-minimis position is TWD 2,000, and only twice in any six-month window per consignee. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Keelung.

What certification do I need for Taiwan?

For regulated goods, plan for: BSMI commodity inspection mark for electrical and consumer goods; NCC approval for radio devices. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Can you ship batteries or sensitive cargo to Keelung?

Yes. Battery cargo by air follows IATA PI 965-970 depending on how the cells are packed, and moves on certified channels via TPE (Taoyuan), KHH (Kaohsiung). Surcharges apply and the declaration has to be made before booking.

Which port or airport does cargo for Keelung clear through?

Cargo for Keelung is routed via Keelung sea. Sea gateways for Taiwan are Kaohsiung, Taichung, Keelung; air gateways are TPE (Taoyuan), KHH (Kaohsiung). We pick whichever gives the shortest total door time for your address.

Is sea freight cheaper than air freight into Keelung?

Per kilo, yes — usually by a wide margin. The trade-off is time: 2-4 calendar days by sea versus 1-2 business days by air to the Taiwan gateway, before clearance and the same-day inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Taiwan duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Customs Administration, Ministry of Finance against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.
