China → Bursa · via IST air / Gemlik sea · clearance by Ministry of Trade — Turkish Customs

We move sea freight cargo from South China into Bursa through IST air / Gemlik sea. Bursa is automotive and textile manufacturing center, which shapes the kind of cargo that moves on this lane and how it should be packed.

On the destination side, Ministry of Trade — Turkish Customs handles clearance; budget 3–8 days of dwell before the cargo is released.

What the routing looks like in practice

Turkey applies the EU common external tariff through its customs union with the EU, and then layers additional duties on a long list of Chinese-origin goods — textiles, footwear, small electronics and some machinery. Those extras, not the base tariff, are what break landed-cost models. Turkey is also served by China-Europe rail via the Middle Corridor into Kars, which sits between air and sea on both cost and transit.

What you will pay on arrival in Turkey

Imports into Turkey are cleared by Ministry of Trade — Turkish Customs. The headline position is: VAT 20%; the EU-Turkey customs union tariff applies, plus additional and anti-dumping duties on many Chinese-origin textiles, footwear and electronics. The de-minimis threshold is EUR 30 on personal parcels, with a simplified flat rate applied to low-value consignments.

Conformity is the part most first-time importers underestimate: CE marking under EU-aligned rules; TSE conformity and TAREKS import inspection for regulated goods. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Turkey: Additional and anti-dumping duties on Chinese-origin goods are common and can exceed the base tariff. TAREKS registration is required for controlled products. Verify the current additional duty rate for your HS code before quoting.

Before you book: Bursa checklist

- Check the de-minimis position (EUR 30 on personal parcels, with a simplified flat rate applied to low-value consignments) against your invoice value before you decide how to split the shipment.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Book earlier than the transit time suggests during Sep–Nov, when space on this lane tightens.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Put the Bursa delivery address, contact name and phone number on the invoice, not just the packing list.

Frequently asked questions

How long does shipping from China to Bursa take?

China to the Turkey gateway is 22–30 calendar days. On top of that, allow 3–8 days of clearance with Ministry of Trade — Turkish Customs and a same-day inland leg to Bursa.

What duty and tax will I pay importing into Bursa?

Ministry of Trade — Turkish Customs applies: VAT 20%; the EU–Turkey customs union tariff applies, plus additional and anti-dumping duties on many Chinese-origin textiles, footwear and electronics. The de-minimis position is EUR 30 on personal parcels, with a simplified flat rate applied to low-value consignments. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Bursa.

What documents does Ministry of Trade — Turkish Customs require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (CE marking under EU-aligned rules; TSE conformity and TAREKS import inspection for regulated goods).

We prepare and file these as part of the service.

When is the busiest time on the China–Turkey lane?

Space and rates tighten around Sep–Nov, plus the China-side windows of Chinese New Year in January or February and Golden Week in early October. Book one to two weeks earlier in those periods.

Can you deliver door-to-door in Bursa?

Yes. Delivery to a Bursa address is quoted as one figure covering freight, duty and tax owed to Ministry of Trade — Turkish Customs, and the same-day inland leg. Confirm whether your consignee wants the goods at a warehouse, a marketplace fulfillment center or a shop front, because the last-mile requirement differs.

How is the chargeable weight calculated for Bursa?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

Checking the Turkey duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Ministry of Trade — Turkish Customs against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

If you want to sanity-check a duty figure yourself, start from the heading rather than the product name — [the WCO Harmonized System](#) is the underlying nomenclature, and [the WTO Tariff & Trade Data portal](#) holds the applied rates by country pair.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.

On the origin side, export declaration and any commodity inspection requirement fall under [China Customs \(GACC\)](#); we handle that filing as part of the service, but the requirement is theirs, not ours.

If this is your first shipment into Turkey, the [Turkey Country Commercial Guide](#) covers the practical import environment in more depth than a rate page reasonably can, and it is written by a party with no stake in your booking.
