China → Kharkiv · via Warsaw air transit / Gdansk sea transit · clearance by State Customs Service of Ukraine

For buyers shipping into Kharkiv, the practical question is not the ocean or flight time but what happens after arrival. Kharkiv is north-eastern industrial center; cargo enters through Warsaw air transit / Gdansk sea transit, and allow +3 days for the inland leg on top of clearance.

The clearing authority is State Customs Service of Ukraine. Historical dwell on this gateway is around 5-15 days, and it lengthens in Sep-Nov.

Duty, tax and clearance into Kharkiv

State Customs Service of Ukraine assesses duty and tax on cargo arriving for Kharkiv consignees. Current regime: VAT 20%; customs duty 0-20%, with a de-minimis position of EUR 150 for personal consignments.

Conformity is the part most first-time importers underestimate: Technical regulations increasingly aligned to EU rules; UkrSEPRO conformity for some categories. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Ukraine: No direct air service; all air cargo routes overland from a neighboring EU country. War-risk surcharges and insurance conditions apply. Confirm the current status of the Black Sea corridor before committing to a sea routing.

Routing and transit on this lane

Ukrainian civil airspace is closed, so there is no direct air option — time-critical cargo flies to Warsaw, Rzeszów or Bucharest and completes by road. Sea cargo can move through the Black Sea corridor to Odesa, but many shippers still prefer Gdańsk or Constanța plus a truck leg for predictability. War-risk insurance and route conditions must be confirmed at the time of booking.

What to sort out before the cargo leaves China

- Book earlier than the transit time suggests during Sep-Nov, when space on this lane tightens.
- Ask for the HS code in writing from your supplier and verify the Ukraine duty rate against it yourself.
- Confirm the consignee in Kharkiv can act as importer of record — State Customs Service of Ukraine will not release cargo to an unregistered party.
- Compare gross weight against volumetric weight ($L \times W \times H \div 6000$) — the higher figure is what gets billed on air and express.
- Put the Kharkiv delivery address, contact name and phone number on the invoice, not just the packing list.
- Check the de-minimis position (EUR 150 for personal consignments) against your invoice value before you decide how to split the shipment.

Frequently asked questions

How long does shipping from China to Kharkiv take?

China to the Ukraine gateway is 35–50 calendar days including the overland leg. On top of that, allow 5–15 days of clearance with State Customs Service of Ukraine and a +3 days inland leg to Kharkiv.

What duty and tax will I pay importing into Kharkiv?

State Customs Service of Ukraine applies: VAT 20%; customs duty 0–20%. The de-minimis position is EUR 150 for personal consignments. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Kharkiv.

Can you ship batteries or sensitive cargo to Kharkiv?

Yes. Battery cargo by sea moves under UN3480/UN3481 with an MSDS, and the dangerous-goods documentation is prepared as part of the booking into Odesa, Chornomorsk and Pivdennyi — operating with wartime restrictions. Surcharges apply and space is more limited than for general cargo.

What documents does State Customs Service of Ukraine require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Technical regulations increasingly aligned to EU rules; UkrSEPRO conformity for some categories). We prepare and file these as part of the service.

What certification do I need for Ukraine?

For regulated goods, plan for: Technical regulations increasingly aligned to EU rules; UkrSEPRO conformity for some categories. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Is sea freight cheaper than air freight into Kharkiv?

Per kilo, yes — usually by a wide margin. The trade-off is time: 35–50 calendar days including the overland leg by sea versus Not available directly — air cargo transits Poland or Romania and completes by road by air to the Ukraine gateway, before clearance and the +3 days inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Ukraine duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by State Customs Service of Ukraine against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Classification drives everything downstream: the same carton can attract very different duty depending on the heading it lands in, and the structure those headings come from is [the World Customs Organization Harmonized System](#). If your product sits near a boundary between two headings, resolve it before shipping rather than at the border.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.
