China → Luganville · via VLI air / Luganville sea · clearance by Department of Customs and Inland Revenue, Vanuatu

Freight from China into Luganville clears through VLI air / Luganville sea. Luganville is the second town on Espiritu Santo, and allow +2 days for the inland leg on top of clearance.

On the destination side, Department of Customs and Inland Revenue, Vanuatu handles clearance; budget 4–10 days of dwell before the cargo is released.

Routing and transit on this lane

Vanuatu is served by feeder from Fiji, Auckland or Brisbane, so the sailing schedule rather than the distance sets the transit time. Cyclone season between November and April can disrupt both port operations and inter-island distribution, and it is worth building

that into any Q4 or Q1 commitment.

Import duty and tax position for Luganville

Imports into Vanuatu are cleared by Department of Customs and Inland Revenue, Vanuatu. The headline position is: VAT 15%; duty 0-35% depending on commodity. The de-minimis threshold is No practical de-minimis for commercial cargo.

Conformity is the part most first-time importers underestimate: Biosecurity Vanuatu clearance; import permits for controlled goods. Getting this wrong is expensive because it usually cannot be fixed after the cargo has landed.

Restrictions and known friction points for Vanuatu: Cyclone season affects reliability from November to April. Biosecurity clearance required for wood packaging. Feeder frequency is the main scheduling constraint.

Transit shown is China departure to the Vanuatu gateway and excludes the +2 days inland leg to Luganville and 4-10 days of clearance.

Before you book: Luganville checklist

- Budget for the inland leg: +2 days beyond gateway clearance to reach Luganville.
- Compare gross weight against volumetric weight (L×W×H ÷ 6000) — the higher figure is what gets billed on air and express.
- Photograph carton markings and seal numbers before departure — it makes any claim far easier to settle.
- Use ISPM-15 treated pallets. Untreated wood is the most common reason otherwise-clean cargo gets held.
- Confirm the consignee in Luganville can act as importer of record — Department of Customs and Inland Revenue, Vanuatu will not release cargo to an unregistered party.
- Declare lithium batteries, magnets, liquids and powders up front — retro-declaring after booking usually means re-planning the whole shipment.

Frequently asked questions

How long does shipping from China to Luganville take?

China to the Vanuatu gateway is 6–9 business days by air, 22–32 calendar days by sea. On top of that, allow 4–10 days of clearance with Department of Customs and Inland Revenue, Vanuatu and a +2 days inland leg to Luganville.

What duty and tax will I pay importing into Luganville?

Department of Customs and Inland Revenue, Vanuatu applies: VAT 15%; duty 0–35% depending on commodity. The de-minimis position is No practical de-minimis for commercial cargo. Under a DDP arrangement these are pre-paid, so nothing is collected on arrival in Luganville.

How is the chargeable weight calculated for Luganville?

We compare actual gross weight against volumetric weight — length × width × height in centimeters divided by 6000 for air — and bill the greater of the two, rounded up to the next kilogram. Light, bulky cargo is almost always billed on volume.

What documents does Department of Customs and Inland Revenue, Vanuatu require?

A commercial invoice with HS codes, a packing list, the bill of lading or air waybill, a certificate of origin where it lowers duty, and any product certification (Biosecurity Vanuatu clearance; import permits for controlled goods). We prepare and file these as part of the service.

What certification do I need for Vanuatu?

For regulated goods, plan for: Biosecurity Vanuatu clearance; import permits for controlled goods. Missing conformity paperwork is the single most common cause of a hold, and in most cases it cannot be remedied once the cargo has arrived.

Is sea freight cheaper than air freight into Luganville?

Per kilo, yes — usually by a wide margin. The trade-off is time: 22–32 calendar days by sea versus 6–9 business days by air to the Vanuatu gateway, before clearance and the +2 days inland leg. The crossover point is normally somewhere between 100 and 300 kg depending on the density of your cargo.

Checking the Vanuatu duty position yourself

Duty and tax figures on this page are planning estimates. The binding assessment is made by Department of Customs and Inland Revenue, Vanuatu against your declared HS code at the time of entry; where the amount is material, verify the current rate through [ITC Market Access Map](#) before committing to an order.

Classification drives everything downstream: the same carton can attract very different duty depending on the heading it lands in, and the structure those headings come from is [the World Customs Organization Harmonized System](#). If your product sits near a boundary between two headings, resolve it before shipping rather than at the border.

For ocean cargo, restricted commodities move under [the IMO's IMDG Code](#), and the container has to be declared and stowed accordingly. Batteries, flammables and corrosives all have a compliant ocean path; what causes rolled bookings is finding out about them after the container is packed.
